

## LocationBox Terms of Use

The services, geographic data, software code components (“Services”) on [www.locationbox.com.tr](http://www.locationbox.com.tr) are provided by Infotech Bilişim ve İletişim Teknolojileri A.Ş. (“INFOTECH”).
